Assignments are used to apply the lecture content in a creative way utilizing research, technological skills, grammatical skills, and some assignment utilize teamwork and collaboration.

Kaplan assessments are used for the students to utilize practice questions and quizzes for self-assessment regarding NCLEX preparedness and retention of current lecture material

7. What were the findings for this academic year? (2019-2020)

The minimum passing grade for this course is 77%.

The class average for this course was 85% with the lowest grade being 77% and the highest grade being 90%.

8. What is your analysis of the findings?

2019-2020 was our first year under the new and current curriculum. The pass rates and retention reveal an upward trend. 2018-2019 had a total enrollment of 38 students with 14 completing the program and cleared for the NCLEX. In 2019-2020, enrollment in the program was 40 students with 24 completing the program and cleared for the NCLEX.

9. What is the action plan for the next academic year? (2020-2021) Explain.

Unit exams will be moved to Blackboard to better mirror NCLEX testing. Kaplan Testing Services will be replaced with Assessment Technologies Institute (ATI).

Pharmacology content will be transferred from lecture to clinical courses. Project and assignments will be given to engage the students in the utilization of the lecture content and promote better understanding and application of concepts.
