## 5. What are the assessment methods? Are they direct or indirect?

Indirect- students were evaluated on reflection questions and providing evidence of materials and knowledge necessary for their professional portfolio. A rubric was used to grade this assessment.

### 6. What are the assessment goal(s)?

Students will achieve 70% or better proficiency on the grading checklist.

### 7. What were the findings for this academic year? (2019-2020)

This course is only offered in the Spring semester. In the Spring of 2020, 94% of the students exceeded the proficiency level.

### 8. What is your analysis of the findings?

Overall, the students exceeded expectations. This is attributed to increased opportunities in class to discuss requirements and brainstorm elements to include in the reflective statements.

# 9. What is the action plan for the next academic year? (2020-2021) Explain.

The newly designed grading rubrics and instructions which better meet NAEYC assessment requirements will be implemented. The additional project which involves students in advocacy will be assessed to gain data for use in the NAEYC Program Assessment.
