The success rate for this project has continued to improve. In 2019, the success rate was 82%, In 2020, the overall pass rate was 88%. There was a 6% increase from last year in the overall pass rate. Overall, the changes made to this project has been successful and have improved students overall pass rate.

6. What is the action plan for the upcoming academic year? Explain.

This project is a NAEYC key assessment and has undergone additional changes due to accreditation. This project will now have a parent involvement component. Students will continue to create activity plans to implement in the classroom during the 2.5-hour observation. In addition, students will create take-home parent activities for cognitive, affective, physical and language development. Faculty will be specifically looking at these criteria in next year's report.
