

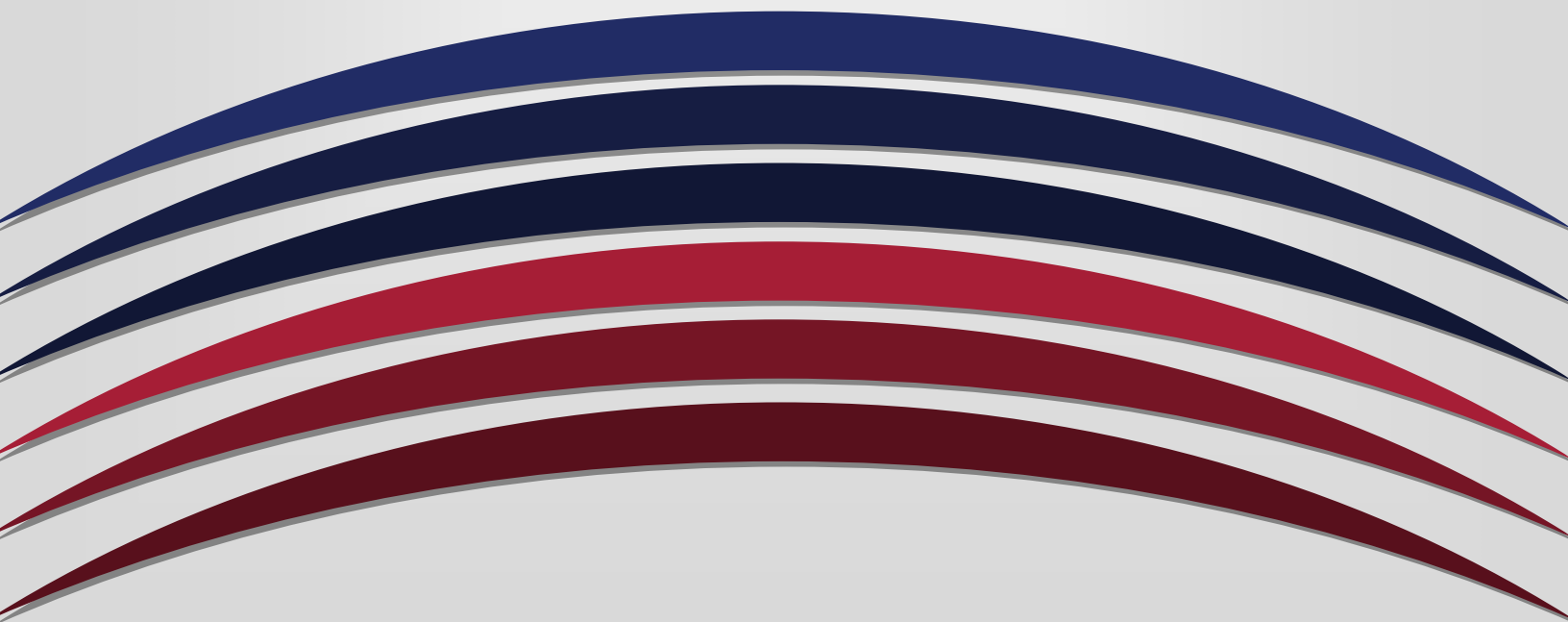

5. What is your analysis of the findings?

For CLO #2 – Use trigonometric relations in solving problems including circular motion, both semesters show a pass rate of over 70% for all methods of course delivery (traditional, online, concurrent). Our goals were met for this learning objective. This CLO#2 relies heavily on students understanding of formulas used for circular motion. Instructors placed continued emphasis on this learning outcome during this academic year.

For CLO #4 - Use appropriate technology, both semesters show a pass rate of over 70% for all methods of course delivery. Our goals were met for this learning objective. However, the traditional and online courses will continue to analyze this outcome. Technology is used consistently throughout the semester. Instructors are regularly working with students to improve technology skills necessary for Trigonometry.

6. What is the action plan for the upcoming academic year?
Explain.

For CLO#1, Develop an understanding of trigonometric functions, instructors will continue to develop the Unit Circle and apply it throughout the semester.

For CLO #3, Develop an understanding of complex numbers and their trigonometric representation, instructors will use pacing guides to ensure enough time will be spent on this material. This learning objective is an application of material taught throughout the semester.

CLO #3, Develop an understanding of complex numbers and their trigonometric representation and CLO #5, Demonstrate an understanding of trigonometric identities, equations, and applications, will be the focus on the 2023-2024 academic year. Instructors will meet at the end of the fall and spring semesters to review results and data will be examined across modalities to consider necessary adjustments for the next academic year.
